Brief: The company is a manufacturer of High Integrity Pressure Regulators. These devices are used to regulate gas pressure and hence increase the safety of the operation in a gas plant





Background / Context: As the Natural Gas Market was growing there was a huge demand for Natural Gas Regulators and ancillary equipment. However, most of the industry continues to be governed by the public sector resulting in procurement through tenders and as per public sector norms

Objectives of the Service : The company although quite sizeable had limited exposure and experience in markets outside its home country. However, given the huge growth in India they were keen to enter the Indian Market and wanted to provide backup support. Allport had to participate in the tender as a local bidder, import the equipment and be well equipped to manage all the obligations including warranty, after sales support locally in India. The vendor had an excellent technology and competitive price but did not have the commercial ability to meet the needs of the procurement process

Steps Taken to Implement the Solution:

- Identification of the opportunity and its feasibility through consultations with the public sector entities
- Location of a suitable supplier with a product that meets the requirements of the tender (zero deviation was a requirement)
- Ensure compliance to all techno-commercial requirements by Allport with technical backup from the supplier
- Import of all the equipment and ancillaries and warehousing in our stock house
- Development of a suitable test lab and showroom for displaying and testing of select models to ensure that they were suitable and re-packaging – Testing Undertaken
- Final Inspection and Dispatch at the Allport Premises
- Stocking, Supply and Distribution to across 7 different locations across the region
- Stock Management of additional units for warranty and after sales
- Warranty and after sales Support where required

Outcome: The goods were imported, tested, inspected and dispatched on site. Some items failed and were brought back for re-testing at the test centre development by Allport. The products were tested and dispatched and have been installed at site. In light of the success a feasibility study was also conducted on the assembly of full regulator stations
